The “Fishing Privileges” subject to this Authorization are all vessel and fishing rights and privileges of any kind or nature; including without limitation, (i) all State of Alaska commercial vessel and fishing licenses and limited entry or interim use permits or cards of any kind, and (ii) all issued pursuant to or arising from the American Fisheries Act, 50 CFR 670.4 et seq, 50 CFR 679.40 et seq., or 50 CFR 680.1 et seq. including without limitation, halibut and sablefish or BSAI crab quota shares and/or the associated individual fishing quota, cooperative rights, LLP permits (including vessel designations on LLP permits), FFP permits, hired skipper cards or permits, any license, permits, or cards relating to those Fishing Privileges, and any interest represented in or by those Fishing Privileges.

This Authorization specifically authorizes Agent to sign, deliver, submit, amend, and pick-up any and all documents relating to the Purpose on my behalf and on behalf of the Authorizing Companies.

I and the Authorizing Companies agree to hold harmless, indemnify, and defend Agent from all losses, expenses, and claims of any kind or nature arising from or related to Agent’s good faith exercise of the Purpose pursuant to this Authorization. This Authorization shall remain valid until revoked in writing.
